Important note to Parent/Carer:

- If you are expressing a preference for a place for your child at this school and wish to apply in connection with one of the faith criteria or the children of staff criterion, you should complete this Supplementary Information Form (SIF).
- If you do not complete the SIF and return it to the school with all supporting documents by the closing date, your child may not be placed in the appropriate faith criterion. This is likely to affect your child's chance of being offered a place.
- For a Reception Year Admission in the normal admissions round for the Year 2024-25, the completed SIF, together with all supporting documents, should be returned to the school by **15 January 2024.**
- For an In-Year Admission in the Year 2024-25, the completed SIF, together with all supporting documents, should be returned to the school as soon as possible.
- If you are applying to more than one Catholic school, you will need to fill out a separate SIF for each school.
- You must also complete the local authority Common Application Form (CAF). The SIF is not valid without the CAF.

Applications for Children of Catechumens / Candidates for Reception - evidence required: If application is being made for a place at the school where the parent/carer is a Catechumen or a Candidate for reception into the Catholic Church, evidence of their being a member of the catechumenate of a Catholic Church or a candidate for reception will be required. Proof of acceptance into the catechumenate, and evidence for a candidate, should be by an original confirmatory letter from the appropriate priest. This evidence should be provided at the same time as this form is returned to the school.

Applications for children who are members of an Orthodox Church - evidence required:

If application is being made for a place at the school where the child is a member of an Orthodox Church, evidence of membership will be required. Membership is normally evidenced by a certificate of baptism/reception into the Orthodox Church. If that is not available, then a letter confirming membership of the applicable Orthodox Church, signed by the appropriate priest, will be required. The certificate of baptism/reception from the authorities of that Church or the letter from the priest confirming membership should be provided at the same time as this form is returned to the school.

Children with Exceptional and Compelling Needs:

Parents/carers wishing to have an Exceptional and Compelling Need considered with their application (criterion 2 or criterion 9 of the Admissions Policy) must submit original independent professional evidence which explains clearly why it is essential to attend St Edmund's Catholic Primary School. The supporting evidence from the qualified professional must detail fully the child's needs and address the reason why these needs can only be met at St Edmund's Catholic Primary School. (The evidence should be addressed to the Chair of Governors and either posted to the school by recorded delivery or, alternatively, handed to the school office and a receipt received). For entry into the Reception Year in September 2024, the evidence should be received by the closing date for applications of 15 January 2024. Please also refer to *note k*. of the Admissions Policy.
